The Legalese will be taught in foreign languages for two hours. The teaching hours will be taught in hour for English and in hour for French. The exam will be from (20) degree and will be allocated (10) degree for each language and will be considered one course and exam

The course of human rights shall be outside the vocabulary of any of the scientific departments in foreign language courses

section (5) : \*A\* The college council is entrusted to one faculty member, teaching the material which the student chooses

\* B\* The Council of the College according to the proposal of the relevant department council, decide every year on its application in some courses, which not exceeding three articles in the academic group

section (6) : \* 1\* The examination shall be writing at the end of the semester, except for the subjects that are extended throughout the year the exam shall be at the end of the year

Section ( 7 ) : \* 2\* The college council may decide oral tests in some courses, but the student may announce this to the students at least two months before the date of the admission

Section ( 8 ) : The duration of the written examination in each course is two hours , The Council of the University at the request of the College Council, amend this period in special circumstances

Section (9) : The maximum test scores for any course (20 degrees)

Section (10) : Five degrees of the total grade is allocated for the mid term

Section ( 11 ) : Success and failure estimates are calculated in the following
